Alderperson Hansen received a call from a local business owner that occupies space in the old post office building at 416 George St. This person had a number of concerns with the location of the Farmers Market, namely that the space is not large enough to accommodate the size of events, with the result that attendees were on the property's lawn and stairs and trying to get into the building during Food Truck Rally. Alderperson Boyd moved, seconded by Alderperson Carpenter to open the meeting. Upon vote, motion carried unanimously. Tina Quigley from Definitely De Pere addressed the concerns and explained their plans to prevent a recurrence at future events. Discussion followed about the perception that there will be a lack of parking during events. City Attorney Judy Schmidt-Lehman pointed out that studies have always shown that the downtown has an abundance of parking if patrons are willing to walk a short distance.

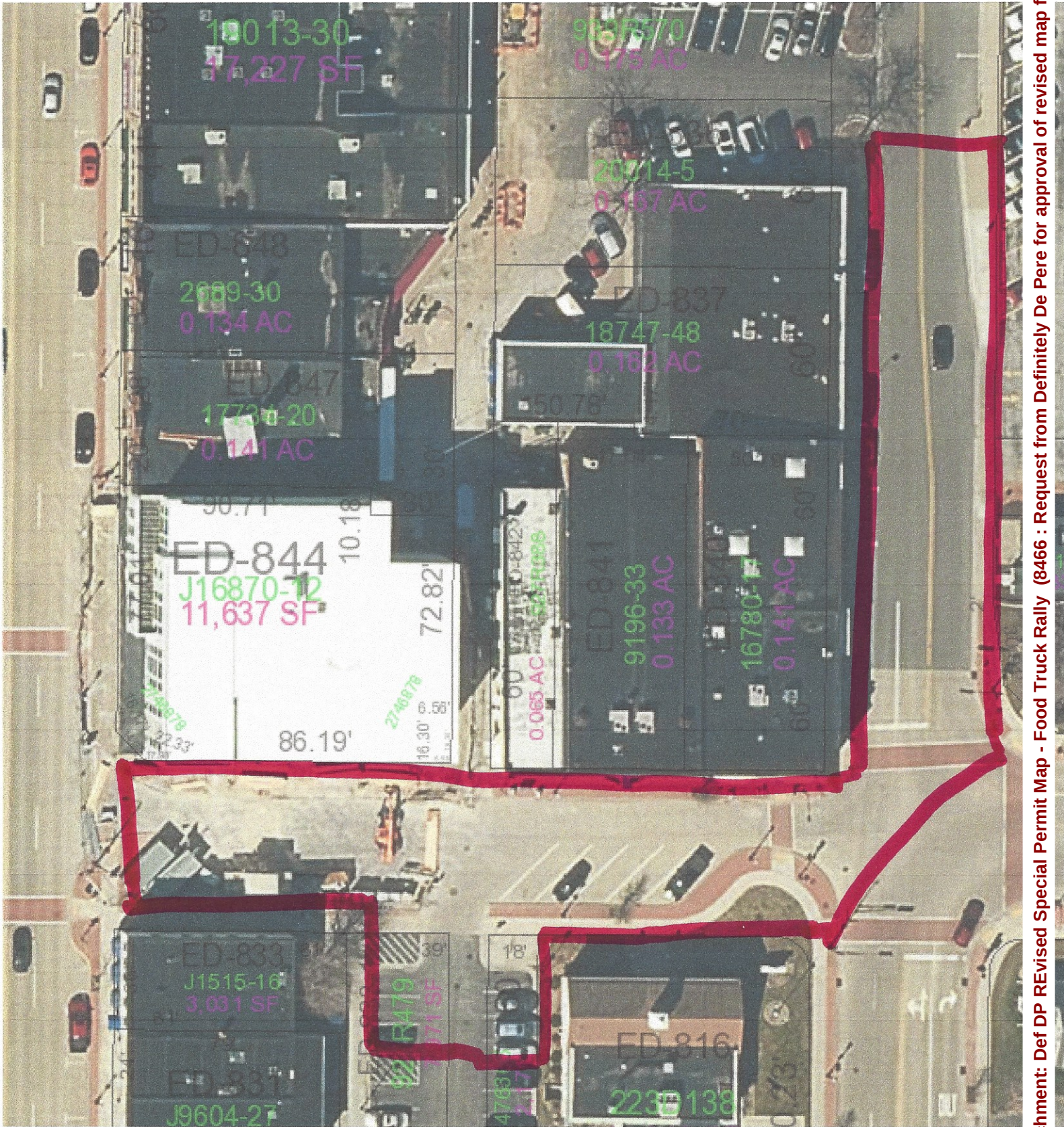
