COMPLAINT

COMES NOW Derek Beiderwieden, Police Chief for the City of De Pere, pursuant to §7-13 De Pere Municipal Code and Wis. Stats. §125.12 who, upon oath, presents this Complaint regarding non-renewal of the Class "B" Fermented Malt Beverage Licenses and "Class B" Intoxicating Liquor Licenses (two Class B Combination Licenses) issued to McLanes Bowl, LLC as follows:

1. I am an adult resident of the City of De Pere and I have held the office of Police Chief for the City of De Pere since June 2, 2002.
2. The City of De Pere issued two Class B Combination Licenses, each consisting of a Class "B" Fermented Malt Beverage License and a "Class B" Intoxicating Liquor License, to McLanes Bowl, LLC, c/o Bryan Kaster, Agent ("Licensee") for the premises doing business as

the Fox y Moo, located at 132 S. Broadway Street, De Pere, WI, for the 2018-2019 license year (July 1 – June 30). A copy of such licenses are attached and incorporated as Exhibit A and Exhibit B. The agent, president, and sole member of McLanes Bowl, LLC, is Bryan Kaster (“Kaster”).

COUNT 1: Allowing Underage Persons on Licensed Premises

3. On May 25, 2019, five underage individuals admitted to being located inside the licensed premises known as the Fox y Moo. The individuals were identified by police officers as: Brian Young, DOB 1/21/1999; Mitchell Anderson, DOB 12/2/1998; Travis Kraft, DOB 5/29/1998; Gabriel Hernandez, DOB 10/20/1998; and Dawsen Wocelka, DOB 7/29/1999.

4. On May 25, 2019, Travis Kraft was issued a municipal citation for underage presence in a place of sale, contrary to Wis. Stats. §125.07(4)(a)(2) and Section 7.125.07 De Pere Municipal Code (DPMC). Travis Kraft’s date of birth is 5/29/1998, making him 20 years old at the time of the offense. Travis Kraft admitted to being located inside the licensed premises known as the Fox y Moo.

5. On May 25, 2019, Gabriel Hernandez was issued a municipal citation for underage presence in a place of sale, contrary to Wis. Stats. §125.07(4)(a)(2) and DPMC Section 7.125.07. Gabriel Hernandez’s date of birth is 10/20/1998, making him 20 years old at the time of the offense. Gabriel Hernandez admitted to being located inside the licensed premises known as the Fox y Moo.

6. On May 25, 2019, Brian Young was issued a municipal citation for underage drinking, contrary to Wis. Stats. §125.07(4)(b) and DPMC Section 7.125.07. Brian Young’s date of birth is 1/21/1999, making him 20 years old at the time of the offense. Brian Young admitted

to being located inside the licensed premises known as the Fox y Moo. A preliminary breath test was administered to Brian Young, with a result of 0.141% breath alcohol concentration.

7. On May 25, 2019, Mitchell Anderson was issued a municipal citation for underage drinking, contrary to Wis. Stats. §125.07(4)(b) and DPMC Section 7.125.07. Mitchell Anderson's date of birth is 12/2/1998, making him 20 years old at the time of the offense. Mitchell Anderson admitted to being located inside the licensed premises known as the Fox y Moo. A preliminary breath test was administered to Mitchell Anderson, with a result of 0.092% breath alcohol concentration.

8. On May 25, 2019, Dawsen Wocelka was issued a municipal citation for underage drinking, contrary to Wis. Stats. §125.07(4)(b) and DPMC Section 7.125.07. Dawsen Wocelka's date of birth is 7/29/1999, making him 19 years old at the time of the offense. Dawsen Wocelka admitted to being located inside the licensed premises known as the Fox y Moo. A preliminary breath test was administered to Dawsen Wocelka, with a result of 0.136% breath alcohol concentration.

9. As a result of the underage individuals' presence inside the licensed premises on May 25, 2019, Kaster was issued a municipal citation for allowing underage individuals on a licensed premises, contrary to Wis. Stats. §125.07(3) and DPMC Section 7.125.07.

COUNT 2: Unreasonable Activity which Substantially Affects the Health,

Welfare, Safety or Peaceful Repose of Area Residents

10. On May 25, 2019, several patrons of the Fox y Moo got into a physical altercation inside the licensed premises. The physical altercation involved the five underage individuals listed above. Another party to the physical altercation was identified by police officers as Charles Cooke, DOB 5/29/1996. Cooke was performing at the Fox y Moo.

11. The physical altercation involving the group of underage individuals and Charles Cooke moved from inside the licensed premises to the parking lot of the Fox y Moo. At one point, Charles Cook retrieved a loaded 9mm handgun and fired a round from the weapon. Cooke has admitted to police officers that he fired a round from the weapon in the parking lot of the Fox y Moo.

12. Criminal charges have been referred to the Brown County District Attorney's Office against Charles Cooke for 2nd Degree Recklessly Endangering Safety, a felony, in violation of Wis. Stats. §941.30(2) and Endangering Safety by Use of a Dangerous Weapon, a misdemeanor, in violation of Wis. Stats. §941.20(1)(a).

COUNT 3: Allowing Underage Person on Licensed Premises

13. On June 16, 2019, three underage individuals admitted to being located inside the licensed premises known as the Fox y Moo. The individuals were identified by police officers as: Alan Rangel-Lopez, DOB 10/24/1998; Ernesto Mendez, DOB 11/20/1998; and Brock Kuhn, DOB 8/22/1998. All three underage individuals indicated to officers that they were not required to present identification at any point to gain access to the licensed premises or while inside the licensed premises.

14. On June 16, 2019, Alan Rangel-Lopez was issued a municipal citation for underage drinking, contrary to Wis. Stats. §125.07(4)(b) and DPMC Section 7.125.07. Alan Rangel-Lopez's date of birth is 10/24/1998, making him 20 years old at the time of the offense. Alan Rangel-Lopez admitted to being located inside the licensed premises known as the Fox y Moo. A preliminary breath test was administered to Alan Rangel-Lopez, with a result of 0.075% breath alcohol concentration.

15. On June 16, 2019, Ernesto Mendez was issued three municipal citations for underage drinking, contrary to Wis. Stats. §125.07(4)(b) and DPMC Section 7.125.07; underage possession of false identification, contrary to Wis. Stats. §125.085 and DPMC Section 7.125.085; and resisting/obstructing, contrary to Wis. Stats. §946.41 and DPMC Section 8.646.41. Ernesto Mendez's date of birth 11/20/1998, making him 20 years old at the time of the offense. Ernesto Mendez admitted to being located inside the licensed premises known as the Fox y Moo and indicated that he was not asked to show identification. A preliminary breath test was administered to Ernesto Mendez, with a result of 0.087% breath alcohol concentration.

16. On June 16, 2019, Brock Kuhn was issued a municipal citation for underage drinking, contrary to Wis. Stats. §125.07(4)(b) and Section 7.125.07 De Pere Municipal Code (DPMC). Brock Kuhn's date of birth is 8/22/1998, making him 20 years old at the time of the offense. Kuhn admitted to being located inside the licensed premises known as the Fox y Moo and indicated he was not asked to show identification. A preliminary breath test was administered to Kuhn, with a result of 0.064% blood alcohol concentration.

17. As a result of the underage individuals' presence inside the licensed premises on June 16, 2019, Kaster was issued a municipal citation for allowing underage individuals on a licensed premises, contrary to Wis. Stats. §125.07(3) and Section 7.125.07 De Pere Municipal Code (DPMC).

COUNT 4: Running a Disorderly House

18. The combined events of May 25, 2019, and June 15, 2019, constitute the running of a disorderly house in violation of Wis. Stats. §125.12(2)(ag)(2) and De Pere Municipal Code (DPMC) §7-13(c)(1).a

Jurisdictional Requirements

19. All ordinances referenced herein and adopted by the City of De Pere in Chapter 7 DPMC have been so adopted under the authority of Wis. Stats. §125.10.

20. All offenses listed above constitute violations of Chapter 125 Wisconsin Statutes and/or Chapter 7 De Pere Municipal Code and may be considered for purposes of license suspension or revocation under Wis. Stats. §125.12 and Section 7.125.12 DPMC since all occurred within a twelve (12) month period.

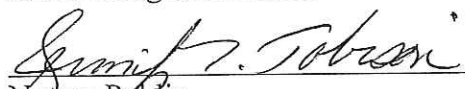
21. The aforementioned allegations are true to the best of my knowledge and belief.

WHEREFORE, Derek Beiderwieden, Chief of Police for the City of De Pere, hereby requests that upon filing of this Complaint, a Summons be issued directing McLanes Bowl, LLC, c/o Bryan Kaster, Agent and Licensee, to appear before the Common Council on June 25, 2019, at 7:00 p.m. for a hearing under §7-13 De Pere Municipal Code and Wis. Stats. §125.12 for the Common Council to consider the non-renewal of the two Class B Combination Licenses issued to McLanes Bowl, LLC, together with such other relief as is allowed by law.
