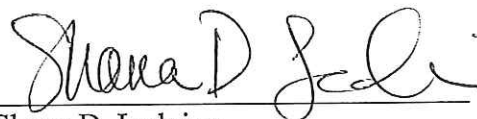

COMPLAINT

COMES NOW Derek Beiderwieden, the Chief of Police for the City of De Pere Police Department, pursuant to §7-13 De Pere Municipal Code and Wis. Stats. §125.12 who, upon oath, presents this Complaint regarding suspension or revocation of the Class "A" Fermented Malt Beverage License issued to Dolgencorp, LLC, d/b/a Dollar General Store, c/o Agent Anthony Hawks, 805 Main Avenue, De Pere, WI 54115 as follows:

1. I am an adult resident of the City of De Pere and I have held the office of Chief of Police since June 2, 2002.
2. A Class "A" Fermented Malt Beverage License was issued to Dolgencorp LLC, d/b/a Dollar General, c/o Agent Anthony Hawks ("Licensee") for the premises located at 805

Main Avenue, De Pere, WI 54115 for the license year commencing July 1, 2017. A copy of such license is attached and incorporated as Exhibit A.

3. On November 7, 2017, Dolgencorp, LLC filed a "Change of Agent" request. The Agent identified in Exhibit A is Deb Jopek. Deb Jopek was replaced by Anthony Hawks as the designated Agent and is currently the registered agent for Dolgencorp, LLC, d/b/a Dollar General Store. A copy of the Change of Agent form is attached and incorporated as Exhibit B.

4. On Wednesday, September 7, 2016, Sgt. Jeremy Schnurer was conducting a compliance check at the Dollar General Store located at 805 Main Avenue, De Pere, WI 54115. Sgt. Schnurer made contact with Scott Mulhern, DOB 8/17/1965, (Mulhern) who was an employee of the Dollar General Store and the only employee working on the date and time. Upon request, Mulhern retrieved his Servers License from the back room. Upon retrieval, it was noted that Mulhern's Servers License had expired June 30, 2016. Mulhern was issued a ticket for No Licensed Operator on Premises in violation of 7.125322 DPMC. Mulhern was found Guilty by the De Pere/Ledgeview Joint Municipal Court of No Licensed Operator on Premises on November 2, 2016. The Judgement of Conviction is attached and incorporated as Exhibit C.

5. On Friday, March 3, 2017, at approximately 6:47 p.m. the De Pere Police Department conducted a compliance check on the Dollar General Store located at 805 Main Avenue, De Pere, WI, which included the use of an 18-year-old confidential informant (CI), sent into the licensed establishment to attempt to purchase alcohol beverages.

6. An undercover De Pere police officer was in the Dollar General Store at the same time as the CI in order to witness the transaction.

7. The CI brought a 6 pack of Bud Light fermented malt beverage to the checkout counter. The CI made contact with Cynthia A. Jansen, DOB 2/26/1961, (Jansen) an employee of

the Dollar General Store. The CI offered the 6 pack of Bud Light to Jansen for purchase. Jansen attempted to process the sale of the Bud Light. Jansen did not ask the CI for identification, but did request a birthdate. The CI gave Jansen the CI's actual birthdate. Jansen entered the birthdate twice, but the Dollar General computerized register system rejected the sale based on this birthdate. Jansen then entered a generic birthdate which would have made the CI over the age of 21-years-old. The sale was processed and the CI left the Dollar General with the Bud Light. The undercover officer witnessed the sale.

8. Jansen was issued a citation for Sell/Procure/Furnish to Underage Person 1st in violation of Wis. Stats. §125.07(1)(a)(1) and 7.125071a DPMC. Jansen was found Guilty by the De Pere/Ledgeview Joint Municipal Court of the offense on March 20, 2017. The Judgment of Conviction is attached and incorporated as Exhibit D.

9. On Tuesday, September 19, 2017, at approximately 1:15 p.m. Officer Charles Leiterman made a quarterly alcohol operator license check at the Dollar General Store, 805 Main Avenue, De Pere, WI. Upon making contact with the employees, Officer Leiterman ascertained that while these employees were working that transactions for the sale of alcohol had taken place. Officer Leiterman requested to see the person who held the operator license necessary for the store to sell alcohol. No one employed on this date during the sales of alcohol possessed an operator license.

10. Officer Leiterman spoke with the District Manager Anthony Hawks, DOB 3/13/1984, (Hawks). Hawks indicated that he was the new manager of the store. Hawks was issued a citation for No Licensed Operator on Premises in violation of 7.125322 DPMC. Hawks was found Guilty by the De Pere/Ledgeview Joint Municipal Court of the citation on October 2, 2017. The Judgment of Conviction is attached and incorporated as Exhibit E.

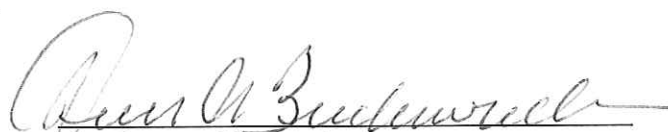
11. All ordinances adopted by the City of De Pere in Chapter 7 DPMC have been so adopted under the authority of Wis. Stats. §125.10.

12. All offenses and convictions listed above occurred constitute violations of Chapter 125 Wisconsin Statutes and Chapter 7 De Pere Municipal Code. The offenses occurring on March 3, 2017 and September 19, 2017 may be considered for purposes of license suspension or revocation under Wis. Stats. §125.12 and Section 7.125.12 DPMC since both occurred within a twelve (12) month period.

13. The aforementioned allegations are true and to the best of my knowledge and belief.

WHEREFORE, Derek Beiderwieden, the Chief of Police for the City of De Pere Police Department, hereby requests that upon filing of this Complaint, a Summons be issued directing Anthony Hawks to appear before the Common Council on January 30, 2018 at 6:00 p.m. for a hearing under §7-13 De Pere Municipal Code and Wis. Stats. §125.12 for the Common Council to consider the suspension or revocation of the Class "A" Fermented Malt Beverage license issued, together with such other relief as is allowed by law.

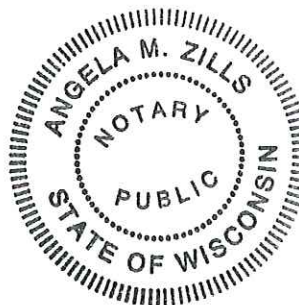

5. On September 28, 2017, Licensee was found guilty by the De Pere/Ledgeview Joint Municipal Court of such charge of permitting the consumption of alcohol beverages on a public places. A certified copy of the Judgment of Conviction is attached hereto and incorporated as Exhibit B.

6. On June 10, 2017, Licensee was working as the manager at the Longbranch Saloon when the De Pere Police Department responded to a complaint of underage persons at the Longbranch Saloon. Upon arrival, the De Pere police department issued citations to twelve (12) underage persons for being on said premises.

7. Licensee was issued one municipal citation for permitting an underage person on the licensed premises of the Longbranch contrary to Wis. Stats. §125.07(3)(a) and Section 7.125.07 DPMC for said June 10, 2017 incident .

8. On September 28, 2017, Licensee was found guilty by the De Pere/Ledgeview Joint Municipal Court of such charge of permitting an underage person on the Longbranch Saloon premises. A certified copy of the Judgment of Conviction is attached hereto and incorporated as Exhibit C.

9. All ordinances adopted by the City of De Pere in Chapter 7 DPMC have been so adopted under the authority of Wis. Stats. §125.10.

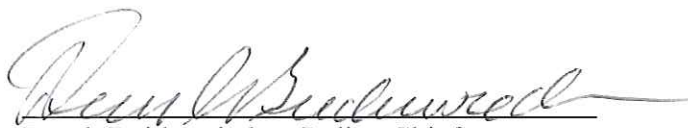

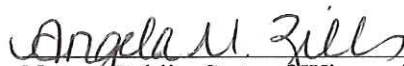
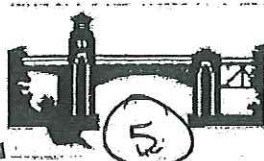
